


The Community Recreational Park Project

Like many small rural areas, Shelby is seeking ways to draw in more residents and increase the size of the business community. Parks are an excellent investment toward those goals. Memories are formed and friendships are forged in community parks.

Although Shelby Township has many green spaces, it doesn't have a multi-sport recreational park. That is about to change.

A 35-acre parcel has been gifted to Shelby Township for a comprehensive \$5.2 million community park. The land is located approximately two miles northwest of downtown, on the Hart-Montague Trail.




This unique park will include:

Target Completion in 2025

- o facilities for organized sports
 - softball and soccer fields
 - volleyball
 - pickleball courts
 - horseshoe pits
- o a playground with structures for ages 2-5 & 5-12
- o an outdoor fitness area with shade canopy
- o a picnic shelter
- o community amphitheater
- o connections to the Hart-Montague Trail
- 1.3 miles of walking trails
- amenities such as a concessions building, pavilion, restrooms, and plenty of parking

The handicap-accessible park will fill a vital role for both visitors and residents. It will be free and safe for all to use, offering beautiful spaces and amenities that can improve physical and emotional wellbeing.

Planners estimate that it will draw approximately 8,000 visitors per year.



The Only Park of Its Kind in Oceana County

The Shelby Township Board is intent on creating the infrastructure that will attract families, encourage business development, and improve quality of life. The community recreational park project is an important cornerstone of this work.

What will it provide?

It will make outdoor space accessible to all.

This park's comprehensive design embraces everything from organized sports to pickup games; from individual walks to group picnics and events. It will be an accessible, safe and welcoming place for everyone.

It will be the cornerstone for destination tourism.

With its proximity to major highways, the Shelby Community Park will be an easy day trip from virtually anywhere in West Michigan. It will also be a natural stop for anyone using the Hart-Montague Trail or visiting Silver Lake Sand Dunes. And what will all those people want to round out their wonderful park experience? Places to eat, shop and explore before heading home. That will fuel business growth.

The park will be a community magnet.

The sheer size of this park, combined with its location, creates a wealth of new opportunities for community engagement. There's talk of recreation programs for youth and adults, of a Farmers Market, of concerts, art exhibits and so much more.
